Confidentiality & Practical Information

Your Coretalents Analysis

Before participating in the program, it is essential that you know your own coretalents constellation. Once the program has started, it is virtually impossible to have your coretalents profile determined (or to determine it yourself) without bias.

Ideally, you have already undergone a coretalents analysis or discovery with one of our 600+ Certified Coretalents analysts. If this is not yet the case, we strongly recommend that you do so now. If that is no longer possible, please contact Coretalents or one of the trainers as soon as possible.

Confidentiality

Whereas:

- Coretalents has developed the Coretalents Method using various documents and tools related to the “coretalents” identified and developed by Danielle Krekels, hereafter referred to as the “Creation”. This Creation is protected and contains confidential know-how, such as technical, operational, financial or business information, including but not limited to documents, presentations, sketches, samples, plans, software, hardware and other materials (hereafter “know-how”) that are exchanged with the participant and designated as confidential, or that by their nature should be considered as such.

- The participant has enrolled in the basic training program to become a Coretalents analyst and, as a result, gains knowledge of the creation and the know-how aiming at, after successfully passing the three exams and obtaining the license, using the creation and the know-how with Coretalents' approval for as long as the license remains valid.

1. The participant does everything to treat the creation and the know-how as strictly confidential and, in particular, shall not reproduce, make available, allow access to, disclose, or have the creation and the know-how processed by any AI program, application or system, unless the participant obtains prior written consent from Coretalents.

2. The participant shall not sell and/or disclose the creation and the know-how for his own benefit or for the benefit of third parties, unless in alignment with the execution of coretalents analyses.

3. The obligations of this annex do not apply to any information:

- (a) which the participant can prove was already in his or her possession prior to the signing of this agreement, provided that the participant immediately notifies Coretalents of this in writing; or
- (b) which is publicly known through no fault of the participant; or
- (c) that has been made public without reservation by Coretalents; or
- (d) that must be made public pursuant to a government order or pursuant to the application of the law, provided that the participant immediately notifies Coretalents thereof and allows Coretalents the opportunity to take measures to protect the creation and the know-how.

4. The obligations under this annex however, shall be perpetual and shall only terminate when and to the extent that Coretalents releases the creation and the know-how.

5. In the unlikely event that you fail one of the exams to become a Coretalents analyst, you are not permitted to continue using Coretalents' materials, except for your preparation for the retake exam. If you fail that as well, you may not use any of these materials, to prevent improper use of our method.

6. The participant acknowledges that a breach or threatened breach of this agreement may cause irreparable harm to Coretalents, and that Coretalents may use all legal remedies available to prevent such a breach, have it ceased, and/or obtain compensation for damages.

Re-Examination

Participants who do not pass the final certification exams may retake them during a later session, after completing additional assignments or coaching if required.

To participate in this retake, an additional fee of € 950 will be required. Additional training will be charged at € 495 per half day.

Licence and certification

After attending all training days and successfully completing the three exams, the participants will receive the Certified Coretalents Analyst license and, if so desired, will be listed on our website.

The certification as a Coretalents Analyst remains valid subject to certain conditions.

To ensure the quality of the Coretalents method, analysts are required to attend at least two half day online consolidation trainings per year. This

allows them to keep skills up to date, deepen knowledge and stay informed of all new insights.

The annual fee for this consolidation training is € 1.450 (excl. VAT). This fee also includes the use of 10 Coretalents questionnaires, downloading the mandatory automated reports linked to these questionnaires, and the creation of the MyCoreTalents profiles.

During the first six months after graduation, this package (consolidation training, 10 questionnaires, reports & MyCoretalents) is included in the training fee.

Additional questionnaires and reports can be purchased at any time for € 65 (excl. VAT) per unit. Note that no questionnaires may be sent out other than via the Coretalents platform.
